Subscription Renewal – Season 2007/2008

Members are reminded that playing subscriptions are due and payable on 1st September.

The standard rates of subscription are as follows:-

(i) For payment by monthly or quarterly Standing Order, **£195**. For playing members **who are full time students, or are under 22 as at 1st September 2007**, the rate is **£135**.

(ii) Playing members who pay in full by one lump sum before 1st September or by Annual Standing Order will continue to receive a discount of **£10, making the rates £185 & £125**.

Standing Order amounts are therefore

**£185 per annum, £48.75 per quarter or £16.25 per month
for Full Adult Membership**

or

**£125 per annum, £33.75 per quarter or £11.25 per month
for Students and Members under 22.**

Please note that payments by cash, cheque, direct transfer or any other method other than Standing Order, will carry a surcharge of £5 making the amounts £200 & £140. Subscriptions received before 30th September will be exempted from this charge.

(iii) For playing members **who are under 18 or are still at school on 1st September 2007**, the rate is **£40, payable in one lump sum**. This includes free access to the Youth Coaching programme.

(iv) **Indoor Subscription: £50**. Irregular Indoor players will be asked for a match fee of £5 per session up to a maximum of four sessions after which the £50 subscription will become payable.

(v) **Non-playing members: £15.**

Those members who are not already paying by Standing Order are urged to do so, as this greatly improves the club's cash flow and eases administration.

If you are already paying by Standing Order please contact your bank prior to 1st September with the new amount. If you wish to start paying by Standing Order, or to change the frequency of your Standing Order, you should complete the form on the reverse and return it to me at the above address as soon as possible and before 1st September.

Please Note: It was decided at our 05/06 AGM that only those who have paid up in full, or completed a standing order form, will be selected to play after the end of October.
